- 1. Staff will meet weekly and evaluate data to monitor progress of each individual student. Students not meeting the 73% mastery goal will be identified. Staff will consult with each atrisk student.
- 2. At the end of each trimester, staff will identify training that will help them better understand students' needs that hinder them from reaching 73% mastery.
- 3. Staff will use Trustlands funds to attend specific training, including At-Risk Conference, Gang Conference, Troubled Youth Conference, etc. that will better prepare them to help at-risk students.

- 1. Staff met weekly, evaluated data and monitored progress of each student. Students identified as not meeting 73% mastery goal were met with individually by assigned staff member.
